**ORDER HOLDING RESPONDENT IN CONTEMPT  
FOR FAILURE TO PAY CHILD SUPPORT, GRANTING  
JUDGMENT FOR ARREARAGES, AND SUSPENDING COMMITMENT**

On June 7, 2002 the Court heard Movant's Motion for Enforcement of Child-Support Order.

***Appearances***

Movant, LINDA LOUISE STALL, appeared in person and through attorney of record, JUDITH E. BLANCHARD, and announced ready for trial.

Respondent, DAVID K. STALL, appeared in person and through attorney of record, JEREMY DUCOTE, and announced ready for trial.

***Proceedings***

All matters of law and of fact were submitted to the Court, and the Court heard the evidence and considered the pleadings and argument of counsel.

***Jurisdiction***

The Court finds that it has jurisdiction over the subject matter and the parties in this case. All persons entitled to citation were properly cited.

***Record***

The record of testimony was duly reported by the court reporter for the 306<sup>TH</sup> Judicial District Court.

## *Findings*

The Court finds that on February 9, 1999 Respondent was ordered to make periodic payments of child support, in an order Cause No. 97-42118, styled "In the Matter of the Marriage of David Keith Stall and Linda Louise Stall and in the Interest of Lauren Louise Stall and Jacob Daniel Stall, Minor Children," in the 311<sup>th</sup> Judicial District Court of Harris County that appears in the minutes of the Court and states in relevant part as follows:

**"IT IS ORDERED AND DECREED** that **DAVID KEITH STALL** is obligated to pay and shall pay to **LINDA LOUISE STALL** and, subject to the provisions for withholding from earnings for child support specified below, child support for **LAUREN LOUISE STALL** and **JACOB DANIEL STALL** of \$1230.00 per month in two equal payments of \$615.00, with the first payment of \$615.00 being due and payable on February 15, 1999, and a like payment being due and payable on March 1, 1999, and an equal installment of \$615.00 due on each and every 1<sup>st</sup> and 15<sup>th</sup> day of each month thereafter until the date of the earliest occurrence of one of the following:

1. any child reaches the age of eighteen years, provided that, if the child is fully enrolled in an accredited secondary school in a program leading toward a high school diploma, the periodic child-support payments shall continue to be due and paid until the end of the school year in which the child graduates;
2. any child marries;
3. any child dies;
4. any child's disabilities are otherwise removed for general purposes;
5. any child is otherwise emancipated; or
6. further order modifying this child support.

"Thereafter, upon the occurrence of one of the above events, **IT IS ORDERED** that **DAVID KEITH STALL** shall pay to **LINDA LOUISE STALL** child support of \$950.00 per month, payable on the 1<sup>st</sup> day of each month until the next occurrence of one of the above events."

The Court further finds that Respondent has failed to comply with the provisions of the order as follows.

***Contempt Findings and Findings on Arrears***

The Court finds that Respondent has failed to pay child support as ordered to **LINDA LOUISE STALL** through the Harris County and Galveston County child support offices in the amounts and on the dates shown on the attached Exhibit A incorporated herein for all purposes as if set forth in its entirety.

The Court finds that Respondent was able to pay child support in the amounts and on the dates ordered as set out above and that Respondent is guilty of a separate act of contempt for each such separate failure to pay child support in the amounts ordered.

More specifically, the Court finds that Respondent has failed to pay child support as ordered to **LINDA LOUISE STALL** through the Harris County and Galveston County Child Support Offices and is in arrears in the following amounts:

February 15, 1999 through May 30, 2000	\$ 83.54
June 1, 2000 through June 30, 2001	\$ 4,464.09
July 1, 2001 through December 31, 2001	\$ 2,220.00
January 1, 2002 through May 31, 2002	\$ 707.25

The Court further finds that on the day of this hearing Respondent has the ability to comply with the order of the Court by paying the child-support arrearages set forth in the violations enumerated above.

The Court further finds and confirms that Respondent is in arrears in the amount of \$7,474.88 for the period February 15, 1999 through May 31, 2002 and that interest has accrued

on those previously unconfirmed arrearages in the amount of \$234.71. Judgment should be awarded against Respondent in the total amount of \$7,709.59 for the arrearages and interest.

The Court further finds that attorney's fees and costs of \$5,233.00 provided by Movant's attorney to enforce child support should be assessed against Respondent. A judgment should be awarded against Respondent in the total amount of \$5,233.00 for attorney's fees, plus six percent (6%) simple interest. The judgment for attorney's fees is for the purpose of collecting child support and is not dismissible in bankruptcy.

The Court further finds that, at the time the motion requesting withholding from earnings for child support was filed, Respondent had been in arrears for an amount due for more than thirty days and the amount of the arrearages was an amount equal to or greater than that due for a one-month period.

The Court further finds that all arrearages, current child-support amounts and attorney's fees should be withheld from Respondent's earnings.

***Relief Granted***

**IT IS ADJUDGED** that Respondent, **DAVID K. STALL**, is in contempt for each separate violation enumerated above.

***Criminal Contempt***

**IT IS ORDERED** that punishment for each separate violation is assessed at confinement in the county jail of Galveston County, Texas, for a period of ten (10) days.

**IT IS THEREFORE ORDERED** that Respondent is committed to the county jail of Galveston County, Texas, for a period of ten (10) days for each separate violation enumerated above.

**IT IS ORDERED** that each period of confinement assessed in this order shall run and be satisfied concurrently.

***Civil Contempt***

**IT IS ORDERED** that Respondent, **DAVID K. STALL**, shall thereafter be further confined in the county jail of Galveston County, Texas, until Respondent has complied with the following orders. **IT IS ORDERED** that Respondent -

1. pay \$7,709.59, through Evelyn Wells Robison, Galveston County District Clerk, Child Support Department, 722 Moody, Room 404, Galveston, Texas 77550, as child-support arrearage (including any accrued interest); and
2. pay \$5,233.00, as attorney's fees in this proceeding, to **LINDA LOUISE STALL** through Evelyn Wells Robison, Galveston County District Clerk, Child Support Department, 722 Moody, Room 404, Galveston, Texas 77550, for attorney's fees due and owing to **JUDITH E. BLANCHARD** at 16815 Royal Crest Drive, Suite 150, Houston, Texas 77058, for the enforcement of the child support order.

***Suspension of Commitment and Community Supervision***

**IT IS ORDERED** that commitment is suspended and Respondent placed on community supervision for a period of two years on the following terms and conditions:

1. **IT IS ORDERED** that Respondent, **DAVID K. STALL**, pay \$1,500.00, by cash, cashier's check, or money order, to **LINDA LOUISE STALL**, through Evelyn Wells Robison, Galveston County District Clerk, Child Support Department, 722 Moody, Room 404, Galveston, Texas 77550, before 5:00 p.m. on July 1, 2002 as a lump-sum payment on the child-support arrearage and any accrued interest.
2. **IT IS ORDERED** that Respondent, **DAVID K. STALL**, pay \$700.00, by cash, cashier's check, or money order, to **LINDA LOUISE STALL**, through Evelyn Wells Robison, Galveston County District Clerk, Child Support Department, 722 Moody, Room 404, Galveston, Texas 77550, on the first of each month, beginning June 1, 2003 and continuing in the same amount and frequency on the first day of every month thereafter, until Respondent has paid the full child-support arrearage, including any accrued interest, of \$7,709.59 and attorney's fees of \$5,233.00, taxed as costs. **IT IS FURTHER ORDERED** that six percent simple interest will continue to accrue on the unpaid balances.
3. **IT IS ORDERED** that Respondent pay all child support as ordered by the Court at the rate of \$739.55 per month, in two installments per month of \$369.78 each, with the first installment of \$369.78 being due and payable on June 1, 2002, the second installment of \$369.78 being due and payable on June 15,

2002, and a like installment of \$369.78 being due and payable on the first and fifteenth day of each month thereafter for as long as child support is due.

***Judgment***

**IT IS ORDERED** that **LINDA LOUISE STALL** is granted a cumulative judgment for child-support arrearages, attorney's fees and costs, including accrued interest, against Respondent of \$12,942.59, such judgment bearing interest at six percent (6%) simple interest per year from the date this order is signed, for which let execution issue.

***Order for Withholding***

**IT IS ORDERED** that all arrearages enumerated above and all current child-support amounts shall be payable through a withholding from earnings for child support.

**IT IS FURTHER ORDERED** that the withholding from earnings for child support shall be binding on Respondent's present employer and all subsequent employers.

On this date the Court authorized the issuance of an "Order/Notice to Withhold Income for Child Support." The amounts to be withheld from Respondent's disposable earnings are stated in that "Order/Notice to Withhold Income for Child Support," which is wholly incorporated by reference into this order.

Any employer of Respondent is **ORDERED** to begin withholding no later than the first pay period following the date on which the "Order/Notice to Withhold Income for Child Support" is served on the employer. The employer is **ORDERED** to continue to withhold income as long as Respondent remains in employment and child support is due and payable.

***Credit on Child-Support Obligation***

**IT IS FURTHER ORDERED** that all amounts withheld from the disposable earnings of Respondent by the employer and paid in accordance with the order shall constitute a credit

against the child-support obligation. Payment of the full amount of child support ordered paid by any prior court order and by this order through this withholding from earnings shall discharge the child-support obligation. If the amount withheld from earnings and credited against the child-support obligation is less than 100 percent of the amount ordered to be paid by that prior court order and by this order, the balance due remains an obligation of Respondent, and it is **ORDERED** that Respondent pay the balance due directly to the local registry specified below.

***Payment***

**IT IS ORDERED** that all payments shall be made through Evelyn Wells Robison, Galveston County District Clerk, Child Support Department, 722 Moody, Room 404, Galveston, Texas 77550 and then remitted by that agency to **LINDA LOUISE STALL** for the support of the child. **IT IS FURTHER ORDERED** that **DAVID K. STALL** pay all fees charged by that agency.

***Change of Employment***

**IT IS ORDERED** that Respondent and the employer shall notify this Court and Movant by U.S. certified mail, return receipt requested, of any change of address and of any termination of employment. This notice shall be given no later than seven days after the change of address or the termination of employment. This notice or a subsequent notice shall also provide the current address of Respondent and the name and address of his current employer, whenever that information becomes available.

***Clerk's Duties***

**IT IS ORDERED** that, on the request of a prosecuting attorney, the title IV-D agency, Movant, or Respondent, the clerk of this Court shall cause a certified copy of the "Order/Notice

to Withhold Income for Child Support” to be delivered to any employer. **IT IS FURTHER ORDERED** that the clerk of this Court shall attach a copy of subchapter C of chapter 158 of the Texas Family Code for the information of any employer.

***Relief Not Granted***

All relief requested and not expressly granted is denied.

**Order to Appear**




