AGREED TEMPORARY INJUNCTION

This is an open records lawsuit, in which Plaintiffs, Susan Lewis King and Austin King, M.D. (“Plaintiffs”) seek a declaratory judgment, pursuant to the Public Information Act (PIA), Tex. Gov’t Code § 552.325, that certain information collected, assembled, or maintained by Defendant the City of Abilene, Texas (“the City”) is protected from disclosure under the PIA. Should the City release the information that Plaintiffs believe is excepted from disclosure, Plaintiffs’ lawsuit to determine the status of this information would be moot. Accordingly, the parties to this lawsuit have agreed to entry of this Agreed Temporary Injunction.

The Court finds that the Plaintiffs would be irreparably injured if the City disclosed the information and documents identified in Plaintiffs’ Amended Original Petition for Declaratory Judgment, Injunctive Relief, and Application for Ex Parte



Temporary Restraining Order to the requestor because Plaintiffs would be unable to pursue their lawsuit.


IT IS THEREFORE ORDERED that:

The City is restrained from releasing the information that Plaintiffs assert is confidential, specifically any document or information responsive to the Texas Attorney General's rulings OR2016-05287 or OR2016-05982 as described in Plaintiffs' Amended Original Petition for Declaratory Judgment, Injunctive Relief, and Application for Ex Parte Temporary Restraining Order;

A trial on the merits is set for Nov. 21, 2016, at 9 a.m./p.m., on the agreement of all parties;


The City and the Attorney General are exempt from posting bond. The bond for Plaintiffs is set at the sum of \$100 and has previously been paid.




